# STATEMENT

Date of Incident: December 22, 2023

Location of Incident: Corner of Rittenhouse Street and Daviston Street, on sidewalk going East.

Incident: Pit Bull killed our Chihuahua dog

I had taken my three-year-old Chihuahua dog (Theodore) for his afternoon daily walk around the block. The route starts at my home, 48 Daviston Street, Springfield, MA 0108, east towards Sumner Avenue, then taking a right on Rittenhouse Terrace Street to Daviston Street. Right after making a right on Daviston Street while on the sidewalk (100 ft.) with Theo, our neighbor's adult pit bulldog ran out of the backdoor of the house towards us. He ran extremely fast and grabbed Theodore with his mouth and teeth.

I immediately started yelling for help while I grabbed the Pitt bull around his chest and front legs from the back. I fell to the ground with this dog and tried to squeeze him as hard as I could to make him let go of Theodore. The pit bull continued to bite Theodore and voraciously shake him. I continued to squeeze him around his neck from the back. Then he finally let go of Theodore. Theodore was shaking, crying, and bleeding from several different areas on his body.

I immediately picked Theodore up from the ground, cradled him and called the Springfield, Massachusetts Police approximately at 5:28 PM. I called my mother, Norma Bartee-Mitchell who was at home at the time to report the incident.

The owner of the pit bull is Richard Pittman, renter of first floor at 58 Daviston Street, Springfield, MA 01108. This property has a partial fence with no gates.

# STATEMENT

**Date of Incident:** December 22, 2023

**Location of Incident:** Corner of Rittenhouse Street and Daviston Street, on Sidewalk going eastbound

**Incident:** Pit Bulldog attack and killed our Chihuahua dog (Theodore)

My son, Robert Brandon Mitchell and I have lived at 48 Daviston Street for 27 years. We adopted Theodore, a three-year-old Chihuahua from T.J. Oconnel in July 2023. Brandon normally takes Theodore out for his afternoon or evening walks between 4:00 PM and 7:00 PM.

While returning home from the walk, my son makes a right turn from Rittenhouse Terrace onto Daviston Street while using the sidewalk. Approximately 100 to 150 ft on the sidewalk from Rittenhouse Terrace, our neighbor's adult, large Pit bulldog ran out the back door of the house, (first floor of two-level house) towards my son and Theodore. He ran extremely fast, grabbed Theodore by the neck and began to bite and shake him.

After calling the police, my son Robert Brandon Mitchell called me at home. I immediately ran outside to be with my son and Theodore. We waited approximately 15 minutes for the police to arrive in front of our house (48 Daviston Street). The Springfield Police arrived and took the report. An Animal Control agent from T.J. Oconnel arrived within 20 – 30 minutes after the incident. There were at least four Springfield Police officers who responded to this emergency call. I held Theodore in two towels and noticed that he was bloody and deceased. Two police officers and the Animal Control officer witness the condition and deceased state of our dog.

The owner of the pit bulldog is Richard Pittman, 58 Daviston Street, Springfield, MA. (renter) was home but did not answer the door for at least fifteen minutes. A second Springfield Police unit arrived and accompanied the first Springfield Police unit to knock again at the door. The owner of the pit bulldog finally answered the door and spoke with the police. The owner of the pit bulldog came out of the house, past the police and came up to me in front of my house. He attempted to act as if he knew nothing and said he was sorry for my loss. I told him he owed me a dog, in the presence of my son, Robert Brandon Mitchell and at least two police officers who had followed him, as he approached me. He then walked back into his house to speak with the police and Animal Control agent on his front porch.

The Springfield Police and the Animal Control agent stated the only action to be taken was to direct the owner of the Pitt Bulldog to quarantine him within the home boundaries for ten days. I was told that if I see the dog loose outside the home boundaries to call the police.

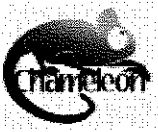

**City of Springfield  
Hearing Request for Dangerous or Nuisance Dogs**

City of Springfield Ordinances: Chapter 110-10 Dangerous Dogs and Nuisance Dogs

Any person may file a complaint in writing to the Advisory and Hearing Committee within 30 days of incident occurrence that a dog owned or kept in the City is a nuisance dog or a dangerous dog. To consider declaring a dog a nuisance dog or a dangerous dog, an Animal Control Officer of the City may initiate a special hearing before the Advisory and Hearing Committee to consider any evidence collected and take charge of and impound the animal. The Animal Control Center shall notify the owner of the dog by certified letter, or Sheriff's Department hand delivery of such special hearing, and the owner may attend and have an opportunity to be heard. Special hearings under this section shall be public meetings under the laws of the Commonwealth of Massachusetts. At this special hearing, the Advisory and Hearing Committee will determine whether to declare such dog a nuisance dog or a dangerous dog, based on the facts presented and the definition of the terms "dangerous dog" and "nuisance dog" in § 110-1.

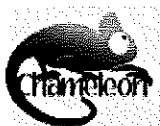
