## Dog Hearing

### 1. Nuisance Dog Hearing for Dog Named Kobe at 77 Bowles St Owned by Michelle Pagan Ramos

#### COMMENTS - Current Meeting:

Read and Attorney Robert Shewchuk read the City of Springfield Ordinance for nuisance dog.

Officer Renee Robichaud from Thomas J. O'Connor (TJO), stated certified mail and regular mail was sent out. On March 1st, 2024, Springfield Police Department called for assistance with an aggressive dog trying to attack Ms. Greer. No bites occurred. Ms. Ramos said the dog belong to her son, who lives in New York. The dog will be returning to New York to live with her son. A citation was sent to Ms. Ramos for the dog being loosed, unvaccinated and unlicensed in the city.

#### Complainant

Ruth Greer stated she is the neighbor of Michelle Ramos. Ms. Greer said, on March 1st 2024, she was taking out her trash with her daughter. She looked over and noticed that Ms. Ramos open her screen door, her main door and let her dog run towards her and her daughter. Ms. Greer said she got between the dog and her daughter. Ms. Greer said she started kicking the dog. Ms. Ramos came down the stairs and said don't kick her dog.

The other incident is when she was walking her daughter to school. Again the dog was let out to poop, and began to chase her daughter. Ms. Greer said Ms. Ramos left the dog alone to go on vacation without any food.

#### Respondent

Michelle Pagan Ramos did not appear.

## 2. **Dangerous Dog Hearing for Dog Names Spencer at 64 Senator St Owned by Nadia Butal & Nasser Harb**

### COMMENTS - Current Meeting:

Read and Attorney Shewchuk read the City of Springfield Ordinance for dangerous dog.

Officer Renee Robichaud from Thomas J. O'Connor (TJO), stated on March 25th 2024, they received a called from the Springfield Police Department regarding a dog attack, dog verses dog. Mr. Diaz was taking his dog, Luna and his trash out. Spencer, owned by Mrs. Butal and Mr. Harb, got loose and attacked Ivan's dog Luna, biting Luna multiply times and physically shaking the dog. Ultimately the dog (Luna) was euthanized at the emergency hospital that evening.

### **Complainant**

Ivan Diaz stated he was doing his routine, he was bringing out his trash barrel with his dog. He was putting down the trash barrel, when two(2) dogs came rushing. By the time he let the trash barrel go and looked. The dogs grabbed, yanked and throwing up his dog Luna. Luna had holes every where from the attack. Mr. Diaz was escorted to West Springfield by the police to try to save his dog. The doctor said there was nothing they can do. His dog passed away. Luna was another family member.

**Atty Shewchuk** asked how can he identify the dog owner.

**Mr. Diaz** said this is the first time he saw them.

**Atty Shewchuk** thanked Mr. Diaz, and said he just want it to be on the record that we are talking about the right dog.

### **Respondent**

Nadia Butal & Nasser Harb said she is sorry for what happened. She said her Spencer is not dangerous. Spencer is sweet and she raised Spencer from a baby. She knows Spencer, this is the first time in two years Spencer skipped the gate. She didn't know what had happened. If she knew Mr. Diaz's address, she would have reached out to him. She doesn't know what happened. She knows her Spencer. Spencer cannot damage anything. Spencer plays with the kids and small dogs. What happened, she don't know. Spencer is vaccinated. Registered and micro chipped.

Mr. Harb said he is really sorry for what happened to Mr. Diaz's dog. If it was him, he would be angry too. Losing a pet is like losing a part of the family. Their dogs are a part of their family. He wanted to reach out and give their condolence. But, he didn't know if it was ok or not. He didn't want to go to Mr. Diaz's house and make him feel uncomfortable in any way. Spencer plays with other dogs, small and big. None of this has ever happened before. He dosen't know what happened. Why Spencer attacked Luna? Spencer is a gentle giant. There is nothing they can say to bring Luna back.

**Rebuttal**

Mr. Diaz said they can say they know their dog, just like he knew his dog, Luna. But, on that day something happened. It's a hard situation for him and his family. It's not fair.

Mr. Harb said he knows it's not fair, but his dog is a part of their family as well. He wished there was something he can do.

**Board Nelson Campbell** asked Mr. Diaz if the dog was on a leash.

**Mr. Diaz** said no.

**Officer Robichaud** said the attack happened on Mr. Diaz's property.

**Board Nelson Campbell** thanked Mr. Diaz and Officer Robichaud.

**3. Dangerous Dog Hearing for Dog Named Harley at 79 Larchmont St Owned by Thomas Perez**

**COMMENTS - Current Meeting:**

Read and Officer Renee Robichaud from Thomas J. O'Connor (TJO), stated on March 22nd, 2024, officer received a called regarding a dog bite incident from the Springfield Police Department. Ms. Graziano was walking down the street, when Thomas was playing fetch with his dog, Harley off leash. Harley chased after Ms. Graziano, while she attempted to walk by Harley bit her on left buttock.

**Complainant**

Marisa Graziano said she was going on her morning walks. Mr. Perez was out on the street with his dog Harley. The dog was not on a leash. She was hesitant to walk, then the dog lunged at her and bit her aggressively. She stumbled into the woods on the right, then the dog was trying to attack her again. Mr. Perez watched his dog bite her. Mr. Perez didn't say sorry. She has two (2) puncture wounds that's not healing the way it should be, it hurts to run and sit. She missed one week of work, she has the doctor's note. She went to Urgent Care, and got a tetanus shot and was put on antibiotics.

**Atty Shewchuk** said this sounds like a civil complaint for damages. This complaint is about the dog and its dangerousness.

Ms. Graziano said that's what she wants.

**Respondent**

Communication: May 2-2024 Minutes (Approval Of Minutes)

Thomas Perez said normally when he gets out of work the first thing he does is let his dog out of his kennel and play catch with him. It's a small private way, it says danger, private way. He saw Ms. Graziano walking up the hill as he's playing fetch with his dog, she looked to be afraid. Harley started to approach Ms. Graziano. Harley is a friendly dog. Mr. Perez ran over to his dog and said Harley come back, come back. As Harley approached Ms. Graziano, she turned very quickly and Harley jumped on her back. Harley did not bite Ms. Graziano, it was Harley's claws that hit her feet. He grabbed Harley, said he was sorry to Ms. Graziano and put Harley in his kennel. He sat there and waited for the Police and Animal Control to come his house, he invited them in, spoke with them and showed them the records for Harley.

**Rebuttal**

Ms. Graziano said she had the puncture wounds as the proof. Mr. Perez watched his dog bite and attack her.

Mr. Perez said when Harley made contact with Ms. Graziano, he grabbed Harley and put him in his kennel.

Officer Robichaud asked Mr. Perez if the city provides services for that private way or does he own it.

Board Member Edwards explained the meaning of private way. He stated that a private way does not mean you own the street, it simply means the street is not paved. The contractor didn't spend the money to pave the street when they finished building the houses.

Officer Robichaud asked Mr. Perez how tall is the kennel.

Mr. Perez said it six (6) feet.

Officer Robichaud asked if the kennel is cement based.

Mr. Perez said he is in the process of getting it done.

**4. Dangerous Dog Hearing for Five (5) Dogs at 101 Quincy St Owned by Kimberly Toote**

**COMMENTS - Current Meeting:**

Read and Officer Renee Robichaud from Thomas J. O'Connor (TJO), stated on March 30th, 2024 TJO received a call from Ms. Reid regarding multiple dogs attacking her as she was

entering her home with her small son. Two (2) dogs jumped on her causing scratches and abrasions, Ms. Reid went to the Hospital for medical treatments. Ms. Reid call the Police Department after returning from the Hospital. TJO Officers contacted the owner and it turns out there are at least five (5) dogs at the resident which is over the limit for the city. All five (5) dogs were placed on quarantine. It appears that none of the dogs are spayed or neutered. The city has a limit for intact animals of three (3) or if they are spayed or neutered the limit would be four (4), otherwise a kennel license would need to be acquired. This property would not meet the requirements for a kennel license within the city.

### **Complainant**

Shadel Reid said it was little after eleven in the morning (11:00 A.M) her and two children returned home. She walked up the stairs as she was heading to the inside door when Kimberly dog came running from the back yard. The biggest dog jumped on her, she tried to shield her four (4) year old. Her and her son was pushed up against the screen door, she hovered over her son the dogs were behind her scratching her. Shadel contacted her grandma, who then contacted the Police Department and TJO. Shadel's major concerns is when she reached out to Kimberly there was no remorse, empathy or nothing. The only way she was able to get the dog off of her is when her fourteen (14) year old son pushed through the screen door, once the door opened she swung her four (4) year old inside the house and still being scratched and clawed. There is no dog sign up, she saw Kimberly on her camera saying to their neighbor sorry I know I am supposed to put up the dog sign, but I didn't put it up. Shadel said Kimberly blamed her autistic son for letting out all five (5) dogs. Shadel said from her understanding, kimberly was told the big dog has to leave, two (2) of the five (5) dogs has to leave and the dogs could not be off a leash if they are outside. On April 1st, her camera caught all five (5) of her dogs outside off leash with her husband. Shadel said her son is petrified of going outside because of to the dogs, he is scared. Shadel said Kimberly son threaten to kill her, and said he will crash out for his dog.

### **Respondent**

Kimberly Toote said she was at work when Shadel texted her. She has the text message Shadel sent her, stating she was attacked by the dog and that she was going to the hospital. She didn't know what to say. Kimberly husband, John Serru says the reason why they have five (5) dogs is because when they bought the house, at the closing it says the property would be fully empty. Mr. Serru says their son was supposed to go downstairs with his two (2) dogs. Kimberly says they already got rid of one dog. Mr Serru says the reason why they didn't have the records was because they were in a bad move and was living in a a hotel for a month and a half. Kimberly says Polie and Silver are going to get their shots and get neuter. She spoke to TJO and she's in compliance with them. Mr. Serru said the reason why the dogs was out is because he goes to work at 4:00 in the morning and he let the dogs out before he goes to work every morning, it's routine for the dogs.

### **Rebuttal**

Shadel Reid said she understand the dog is in a routine, but the dogs were outside off leash. Kimberly was not abiding by what TJO said. It was King that attacked her and she had open abrasions.

Kimberly said Meeko and King are vaccinated. Her dogs jumped on people when they get excited. Kimberly said she did sign up for King and Polie to get fixed.

Atty Shewchuk asked if all the dogs will be fixed.

Kimberly said TJO told her she can keep the four(4) dogs as long as they are fixed

Mr. Serru said he working on getting a fence in the back.

Officer Robichaud asked if silver is spayed

Kimberly said no, he's getting spayed.

4. Provide proof of neutering as soon as possible, and schedule a follow up hearing to make sure the conditions are place.

Renee,

This is Ashley Brennan. First, I do want to say I've exhausted all my options. I have called the animal control main number multiple times which is why I am now reaching out to you. I have been dealing with this dog for 8 months now maybe longer. I made 4 calls (2 to 911) and twice for animal control for thier before I even got mine. I have videos of everything because ADT is my camera system. When I had called those times, I had a lot of scrapewood in my yard from moving so the animal control lady and myself blocked the fence holes thier dog destroyed. It didn't last as the fence is completely fallen down 6 months ago and if it wasn't for me putting 100lbs of leaves and my scrapewood up to block THEIR DOG from breaking through THEIR FENCE, it wouldn't even be held up period. Again, the dog pushes the wood down and gets through the fence because it is NEVER LEASHED OR ON A LINE. she has personally told me "my dog doesn't do lines" (not sure what dog does like then but it's called being responsible. I'm stressed out over this and it's causing my medical issues to worsen. Noone can step foot outside my backdoor AT ANY TIME ANY DAY without that dog viciously trying to bite and break the fence. I can't have people over, I can't have my own dog use her backyard in any fashion whether it be to use the bathroom or play etc, it doesn't matter. At the very least it's harrasment. I've now called in the past 6 months animal control (the number you told me to call in your voicemail) another 5 to 6 times over this dog. They've done absolutely nothing. If my dog uses our backyard I have to watch her and walk with her at all times because of this dog. I can't do yardwork I mean nothing. I cannot stress more how out of control this issue has become. It's so unfair to my family, my son, my dog, and my property that I pay \$2300 a month just on a mortgage for a yard I cannot use. If it eas the other way around I would've handled that fence asap, or bought a 15 dollar line. My dog is a friendly puppy but is on a line and shooed inside approximately 18 times a day because I can't handle being outside. Thier kids jump on a trampoline directly on the other side of this fence. I can't go 50 yards near the fence. Thier dog barges through the fence and chased my 12 tear old son and myself (on another occasion) to my back steps and back door. My dog has never even been near their backyard let alone that close to thier door. My dog doesnt even bark, like at all, thiers doesnt stop. My dog isnt viciously trying to bite thier kids hence they dont feel any fear playing everyday but

my don does. My dog isn't breaking the fence to attack thier dog, but thiers is trying several times a day to get mine. My dog isn't pooping and peeing in thier yard for them to pick up, but thiers is. They should be held accountable to at the very least restrain thier dog. It's thier fence, and they know it. I had the property appraised when I bought the home in August of 2023. If that dog bites my son or my puppy I'm suing them. We had an argument a few weeks back and then this past week I spoke with the owner for over an hour. I have some of that recorded as well. She states "I told my man, if it bites one of y'all oh well let em take the dog". I don't think she understands that's the least of what will happen if my family gets bitten. I'm 100% disabled Combat veteran with a heary and siezure condition. I deployed to Iraq twice and have to be on guard on my own property all day long. If it bites me I'm already disabled so it's not going to be good. It nearly got my dog on Saturday. If it gets my dog around her throat that's it she is done. My dog hasn't been in any type of aggressive fight or anything yet, she would be so submissive if it got attacked. All I'm asking is for animal control to make them responsible for either fixing thier fence or tear it down I don't care but they need to be held responsible for keeping their dog away from my dog and property. After I spoke with her I thought we would be able to come to some sort of civil agreement and her "man" came over on Sunday and asked to go in my backyard to repair some of the fence. I said sure and even offered to help. Mind you he has built garden beds and gazebos in the past 2 weeks with all this spare wood he said he has but hasn't done one thing to block his dog from getting in my yard. He took three 2x4s and nailed them in some of the open areas his dog destroyed. It lasted 2 hours before thier dog busted through the fence panels and got in my yard. I don't think they understand I'm the only one whose made any real attempt to holding the entire thing up to create a barrier or using my wood to block it just for thier dog to push down. If it wasn't for all my leaves back there it wouldn't even be standing. I took pictures of the fence before I lifted it up and put leaves behind it to stand it up. I don't want trash in my backyard. I work VERY HARD on my yard and I'm picking thier dogs poop up. I'll send some videos I've taken just from this weekend through now. I have a ton of evidence. I'm at a loss so I'm not trying to come off rude because I'm actually very friendly but my family is at risk everyday, I'm physically having issues due to the stress this is causing me. I'm crying at night. It's just so unfair to have to live like this. I assure you if it was you or your family you'd be just as upset. Please let me know what happens now with the hearing with the videos I'll attach. But mainly, I need something to happen now with the restraining of the dog because my dog can't even use the bathroom anymore and I can't take my trash barrels in without feeling like it's going to try and run at me. So the reason I was reaching out to you is because nothing has happened in the 8 or more calls I've already made. Also, because I need something to happen today regarding it getting in my yard. Not to mention this fog is abused the owners hit it and so do the kids. I'm sure your not going to believe that but I'll put it out there anyways. Another thing is I'm also sure animal control is getting the gist of things when the knock on their door and the owners greet them and welcome them so the dog acts differently than it would if you walked in my backyard. All I'm asking is for it to leave my family and property alone.

#### Discharge Instructions

Hershey was presented after sustaining dog bite wounds earlier in the evening. Luckily, all of Hershey's wounds were superficial and will heal without needing sutures. We are starting Hershey on an antibiotic since even small puncture wounds from bites are prone to infection. We are also sending home a mild pain medication.

Hershey received a rabies vaccine booster today, he will need his next vaccine in one year.

Monitor all wounds for discharge, redness, swelling, or black appearing skin. A small amount of clear red-tinged discharge is normal, but should be not increasing in amount.

#### Medications:

- Amoxi-Clav Tablets 625mg: Give 1 tablet by mouth every 12 hours for 7 days. This is an antibiotic, give for entire course. Give with food to reduce GI side effects. Start with next meal.
- Gabapentin Capsules 400mg: Give 1 capsule by mouth every 8 hours as needed for pain. May cause mild drowsiness.

If Hershey develops signs of systemic illness such as vomiting, anorexia, profuse diarrhea, or lethargy, contact a veterinarian.

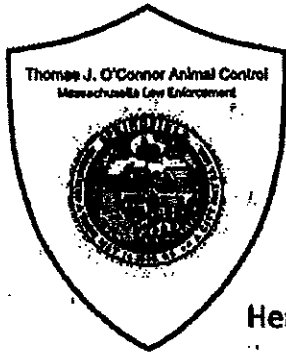

2. Your dogs must be humanely restrained with a leash and muzzled at all times when off the property owned by you. Your dogs may not be walked by anyone under the age 18. Your dogs must be confined securely in your residence or in the secure enclosure outdoors; your dogs are prohibited from roaming loose in your yard at any time and must be walked on-leash from your residence to the secure enclosure when outdoors.
3. That the owner construct, within two weeks from the date of decision, a secure enclosure to house the dog when it is in the owner's yard. The Advisory and Hearing Committee may order that, during the construction period, the dog be publicly impounded at an animal shelter or a private veterinary hospital until the secure enclosure is constructed. The effectiveness of the secure enclosure shall be subject to approval and periodic inspections by an Animal Control Officer, as deemed necessary. The fee for said inspection shall be \$75. If the owner is found violating the secure enclosure requirements, immediate public impoundment of the dog shall be done by the animal control center during the time the violation continues to exist, and the owner shall bear all cost(s) for such public impoundment. The fine for such violation shall be \$200 per day;

Any appeal of this decision may be filed in District Court in according with Chapter 140, Section 157(a) (4) (d) of the Massachusetts General Laws. Further information may be obtained from the Thomas J. O'Connor Animal Control Center, 627 Cottage Street, Springfield, Massachusetts, 413-781-1484.

Any person may file a complaint in writing to the Advisory and Hearing Committee within 30 days of incident occurrence that a dog owned or kept in the City is a nuisance dog or a dangerous dog. To consider declaring a dog a nuisance dog or a dangerous dog, an Animal Control Officer of the City may initiate a special hearing before the Advisory and Hearing Committee to consider any evidence collected and take charge of and impound the animal. The Animal Control Center shall notify the owner of the dog by certified letter, or Sheriff's Department hand delivery of such special hearing, and the owner may attend and have an opportunity to be heard. Special hearings under this section shall be public meetings under the laws of the Commonwealth of Massachusetts. At this special hearing, the Advisory and Hearing Committee will determine whether to declare such dog a nuisance dog or a dangerous dog, based on the facts presented and the definition of the terms "dangerous dog" and "nuisance dog" in § 110-1.

A dangerous dog hearing was held on May 24, 2023 for 460 Canon Circle by the Animal Control Advisory and Hearing Committee in accordance with Chapter 110, Section 10 of the Code of the City of Springfield. At the dangerous hearing, in which you appeared as owner of a Queensland Mix named "Scooby", it was determined by the Animal Control Advisory and Hearing Committee by a unanimous vote to declare your dog as **Dangerous**, and has imposed following conditions

The Committee imposed the following conditions on the animals:


1. The dog be confined to the premises of the owner of the dog; provided, however, that "confined" shall mean securely confined indoors or confined outdoors in a securely enclosed and locked pen or dog run area upon the premises of the owner; provided however, that such confinement shall comply with section 110-8 of this chapter
2. Registration for the dog's microchip must be current.
3. Whenever the dogs are removed from the premises of the Owner, the dogs shall be securely and humanely muzzled and restrained with a chain or other tethering device having a minimum tensile strength of three hundred (300) pounds and not exceeding three (3) feet in length;

If you do not fully comply with the Conditions listed herein within two (2) weeks of the date of this decision, an order will be issue stating the dogs must be euthanized.

You are to meet with representatives from the Thomas J. O'Connor Animal Control & Adoption Center (TJO) to ascertain what steps are required for compliance.

Any appeal of this decision may be filed in District Court in accordance with Chapter 140, Section 157(a) (4) (d) of the Massachusetts General Laws. Further information may be obtained from the Thomas J. O'Connor Animal Control Center, 627 Cottage Street, Springfield, Massachusetts, 413-781-1484.

Dear Kimberly Toote:

A dangerous dog hearing was held on May 2, 2024 by the Animal Control Advisory and hearing Committee in accordance with Chapter 110, Section 10 of the Code of the City of Springfield Ordinance, 2012, as amended for dangerous dog hearing for your five (5) dogs. The committee voted to deem your dogs, King, Silver, Meeko and Polie as a Nuisance and has imposed the following conditions:

The Advisory and Hearing Committee has imposed the following condition on the animal:

1. Neuter all four (4) dogs as soon as possible to be in compliance with the Code of the City of Springfield Ordinance.
2. A secure fence in a portion of the yard to enable tenants to safely enter and exit the property without being accosted by the dogs shall be installed within 1 month. Dogs shall be leashed, and walked only until the fence is installed.
3. Adults only over the age of 18 are allowed to take the dogs in or out.
4. Provide proof of neutering ASAP, and schedule a follow up hearing to make sure the conditions are in place.

Failure to comply with this order may result in a fine of up to five hundred dollars (\$500.00) or imprisonment for up to 60 days under Mass General Law Chapter 140 Section 157a. Please note transferring ownership or possession of your dog in prohibited under subsection (3) of Chapter 140 Section 157A.

An appeal of this decision may be filed in District Court within 21 days of the date of the hearing per Section 110-13(E) of the Springfield, MA ordinance.
