Upon arrival, I spoke with Mr. A [M.G.L.] M [M.G.] who stated his small "sheppie" was attacked by what he believed were 2 pitbull style dogs and has been brought to a veterinarian in West Springfield. Mr. M [M.G.] informed me that a short time prior, his wife had taken their small dog out for a walk while on a leash. Within a few moments of being outside, two unknown dogs ran at them and began to viciously bite and pull at their small "sheppie". Mr. M [M.G.] and his neighbor were eventually able to get the dogs apart, however not before his dog was severely injured. 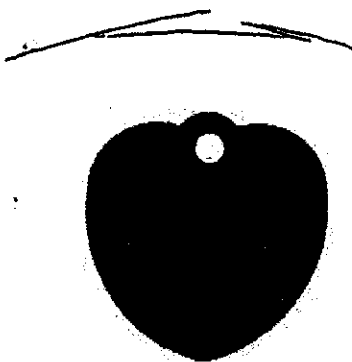

Discharge Instructions

Hershey was presented after sustaining dog bite wounds earlier in the evening. Luckily, all of Hershey's wounds were superficial and will heal without needing sutures. We are starting Hershey on an antibiotic since even small puncture wounds from bites are prone to infection. We are also sending home a mild pain medication.

Hershey received a rabies vaccine booster today, he will need his next vaccine in one year.

Monitor all wounds for discharge, redness, swelling, or black appearing skin. A small amount of clear red-tinged discharge is normal, but should be not increasing in amount.

Medications:

- Amoxi-Clav Tablets 625mg: Give 1 tablet by mouth every 12 hours for 7 days. This is an antibiotic, give for entire course. Give with food to reduce GI side effects. Start with next meal.
- Gabapentin Capsules 400mg: Give 1 capsule by mouth every 8 hours as needed for pain. May cause mild drowsiness.

If Hershey develops signs of systemic illness such as vomiting, anorexia, profuse diarrhea, or lethargy, contact a veterinarian.
