3. That whenever the dog is removed from the premises of the owner, the dog shall be securely and humanely muzzled and restrained with a leash having a minimum tensile strength of 300 pounds and not exceeding three feet in length; As defined in Chapter 110, Section 10-B-3 of the Code of the City of Springfield Ordinance.
4. That the animal shall be surgically sterilized and microchipped with the microchip registered to the City, with all costs associated with these services to be borne by the owner; As defined in Chapter 110, Section 10-B-4 of the Code of the City of Springfield Ordinance.
5. That ownership of the dog may not be transferred unless the transfer of ownership is to an adult residing within the same residence and said dog shall remain housed solely at that residence; As defined in Chapter 110, Section 10-B-6 of the Code of the City of Springfield Ordinance.
6. That, if the owner of the dog fails to appear at a hearing in front of the Advisory and Hearing Committee and the dog is declared a dangerous dog, the dog shall be impounded and/or euthanized. As defined in Chapter 110, Section 10-7 of the Code of the City of Springfield Ordinance.

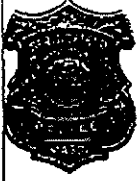

Received a call from Ray Hearn, the Wilbraham Post Master, regarding a dog that was off leash and got within 2" of his postal carrier, Charles Staton.

On arrival, SPD was on scene and Mr. Hearn drove up behind us. There were no dogs loose or outside. ACO Simpson and I went up to speak with the home owner while Mr. Hearn spoke with the police.

Mr. Derrick Cook came to speak with us regarding the dogs, despite Dayna Gomes being the registered owner of 3 of them (Coco, Bully, and Nova). Mr. Cook claims that none of his dogs had been out yet today. He stated that the Postal Carrier has a vendetta against him because he yelled at him once for not delivering his mail. Through the door we could see two bully/pitty type dogs; one blue (Raven?) and one tan brindle looking (Coco?). We advised him on being over the limit for dogs. We also suggested he find an option for his dogs to be out without harrassing the postal carrier. He intends on building a secure enclosure, and has been advised that a shelter would be necessary too.

While speaking with Charles Staton, he had numerous concerns about the dogs being out for too long in addition to being loose. When asked where this incident occurred, he pointed near the front steps of the dog's home. He states that after the mail was delivered, he turned around and the tan dog was right there. He states that it growled and barked at him, baring its teeth, but no bite occurred and he did not deploy his OC spray.

On 6/21/25, I Officer Sanborn received a call from Dayna Gomes, a resident of 1116 Worcester St. in Indian Orchard. She alleges she was outside with her dog Nova and out of nowhere, allegedly Loki appeared and attacked her dog. She provided photos, which depict puncture like injuries to the right jowl area of Nova's face. She advised that allegedly, Luis Guervara did not respond to retrieve his dog. Gomes reports her partner Derek, allegedly was able to grab Loki and secure him in Guervara's yard using a garden hose.

Both Derek and Luis have R/O against each other for past disturbance events.

I advised Gomes I would contact Guervara and complete a report based on the discussions from both dog owners. I further advised Gomes that Nova needd to be seen by a Vet to have the wounds cleaned and evaluated . She indicated financially she could not bring her. I will follow uo to ensure Nova receives care and if not, will consider animal care standard Citation. Gomes also provided time stamped photo of Guervara standing in his doorway, watching as Loki is in the driveway untethered. Loki is on his own property and being monitored by Guervara.

I contacted Loki's owner and he apologized profusely. He alleges his 3yo son opened the screen door and allegedly Loki escaped and it was then he noted Nova in her yard and he allegedly attacked Nova inflicting bites to the right side of her face. Per Gomes, Loki was not injured by Nova.

Guervara also confirmed that Loki did not receive any injuries. He further advised that Loki has has issues with Nova since an event where Nova allegedly entered their home and attacked Loki. He reported his kitchen was a bloody mess.

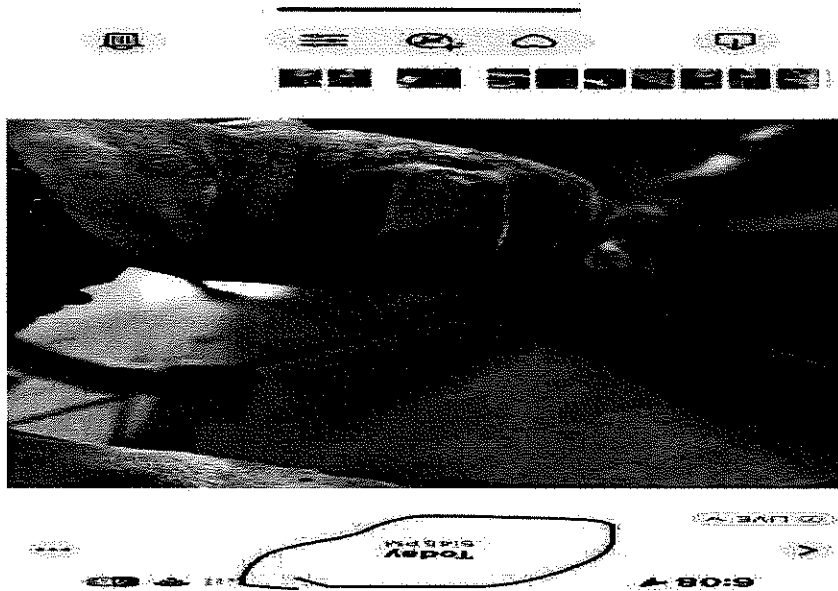
He advised that since then there has been an ongoing dispute between neighbors, resulting in the current R/O of both male parties. Guervara was apologetic and shared that he is a single dad raising 3 kids. Allegedly, his former partner, mother of 2 of the kids moved to Georgia and left behind the kids and 5 pets. He admits he struggles with ownership of Loki and when he discusses rehoming, allegedly the former partner guilts him into keeping Loki. 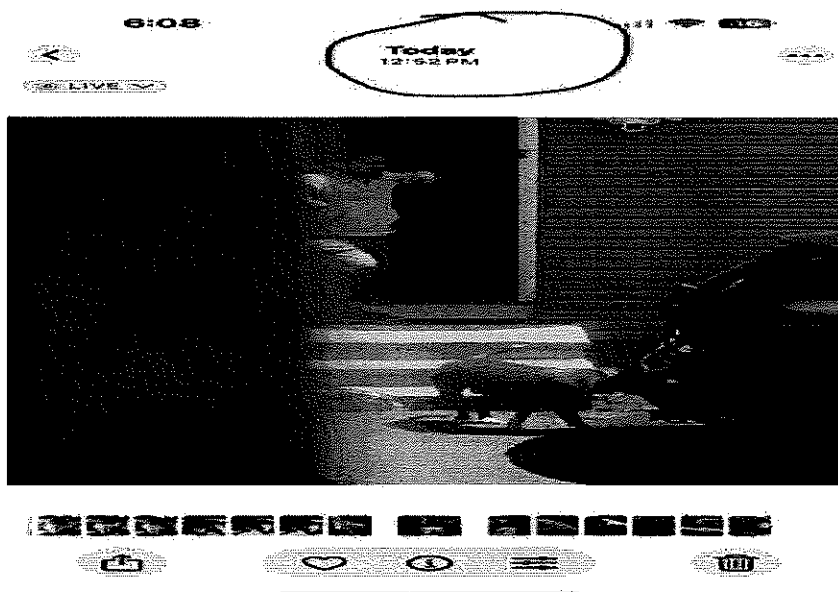

A dangerous dog hearing was held on July 18, 2024 by the Animal Control Advisory and hearing Committee in accordance with Chapter 110, Section 10 of the Code of the City of Springfield Ordinance, 2012, as amended for dangerous dog hearing for your dog named Emmy. The committee voted to deem your dog a **Nuisance** and has imposed the following conditions:

The Advisory and Hearing Committee has imposed the following condition on the animal:

1. The fence to be properly installed within two (2) weeks.
2. Thomas J. O'Connor (TJO) to the visit with in two (2) weeks. As defined in Chapter 110, Section 9 of the Code of the City of Springfield Ordinance.

Failure to comply with this order may result in a fine of up to five hundred dollars (\$500.00) or imprisonment for up to 60 days under Mass General Law Chapter 140 Section 157a. Please note transferring ownership or possession of your dog is prohibited under subsection (3) of Chapter 140 Section 157A.

An appeal of this decision may be filed in District Court within 21 days of receiving this notice per Section 110-13(E) of the Springfield, MA ordinance. Further information regarding the requirements may be obtained from the Thomas J. O'Connor Animal Control Center, 627 Cottage Street, Springfield, Massachusetts, 413-781-1484.
