25-19 No Parking - No Parking Any Time sign in front of 28-30 Mystic Street. Starting from a point 286 feet from the corner of Carew Street westerly direction.

25-20 Stop Sign -- 3 Way Stop Signs at the intersection of Oklahoma Street and Redlands Street.

25-21 Stop Sign – At the intersection of Cedar Street and Pine Street.

25-24 Stop Sign -- At the intersection of Forest Park Ave. and Riverview St. and Forest Park Ave. and Forest St.

25-25 MassDot Stop Signs - 4 Way Stop Signs at St James Ave. and Thompson St.

25-26 Rochelle Street. - Remove the existing "No Parking" restriction from 8:00 AM to 6:00 PM on Rochelle Street.
