NEW BUSINESS

FIRST order of business- Approval of Minutes:

Approval of Minutes for the Taxi and Livery Commission Hearing held on Tuesday, August 8, 2017.

After discussion:

Commissioner Payne motioned to approve the minutes. The motion was seconded by Commissioner Baro with a unanimous vote to approve.
