TJO Animal Control is requesting a nuisance hearing on 3 dogs, "Dutch," "Remy" and "Trinity," that reside with Shaundolyn Bryan at 153 Wrentham Road, Springfield. The dogs are frequently loose; "Dutch" has been impounded at TJO 9 times over the last few years, "Remy" 6 times, and "Trinity" once in 2016. Attached you will find a history regarding this address, including instances involving two dogs previously at the same home (one of those dogs was rehomed through TJO, the other euthanized). You will also find activity reports for visits to the address for well-being checks and loose complaints. Shaundolyn Bryan was previously receiving assistance from Kane's Crusade; because of this, Kim George, the founder and president of Kane's, has agreed that it is most appropriate for her to recuse herself from this individual's hearing. If you have any questions or need additional information please feel free to contact me.

2/16/15-Complaint of small dog owned by Harvey King outside in freezing temperatures; dog was indoors upon arrival of ACO. Akita dog seen outdoors as well.

12/22/16-Complaint of dog outside in cold temperatures and barking; notice left.

1/13/17-Additional barking complaint, citation issued to owner.

1/27/17-Complaint of Akita barking and outdoors in cold weather; ACO made contact with owner; barking not in violation of ordinance at that time.

2/9/17-Complaint of dog out in snowstorm; owner contacted; shelter adequate but owner brought dog indoors as requested by ACO.

2/13/17-Assist with code enforcement for (non-animal) hoarding concerns.

5/12/17-Akita owned by Harvey King escaped enclosure and attacked Shih Tzu dog being walked off leash in area.

As of 5/18/17 the Akita named "Dog" owned by Harvey King is current on rabies vaccination until January 2018; the dog was licensed in 2016 but has not been relicensed for this year; the dg is not neutered.

Received a call from Gary Piznik regarding a barking dog at 38 Begley St. Caller stated the dog had been out for 30-45 minutes barking.

On arrival there was a near constant whine coming from the back yard. The bark was not constant, but in the 5 minutes before the owner arrived, I counted approximately 30 loud barks.

The owner, Mr. Harvey King, arrived and we had a discussion regarding the dog. Mr. King did a great job being as calm as possible, but was very upset. I advised him regarding the barking dog ordinances, but he didn't seem to care about anything I had to say. At one point he ordered me to stop writing notes, but then seemed to think better of his demand.

He did bring me back to see "Dog" who has a large fenced kennel with an Igloo style dog house with an additional sheet metal door to prevent the elements from entering. The dog house also had a lip on the door to minimize exposure and prevent the dog from pulling his bedding out. The Igloo was raised up on a pallet. Dog appeared to be in great condition. His coat was very clean and he was eating a large bowl of dog food. Mr. King stated that he was barking because his dinner was late that evening. (DOG IS VERY FOOD AGGRESSIVE)

Mr. King made several off comments regarding what he would do if he ever found out who was calling. He then asked if I carried a side arm and requested that I "just shoot the dog" next time I get called to his address.

No citations will be issued at this time, because I did not witness barking in excess of 10 minutes. Please exercise caution at this address, as I feel Mr. King is feeling victimized or bullied by TJO and Ordinance.

Concerned citizen call regarding a dog that has been whining for 30 minutes. I knocked upon arrival. The front door was partially ajar. I did not see nor hear a dog. I started to walk away when I noted an African American male walking towards the gate. I asked if he lived there and he said yes. I introduced myself and explained why I was there. He asked if I heard the dog whining or barking and I told him no. I asked him how long the dog had been outside and he proceeded to tell me this long story about neighbor dispute and the same person keeps calling. I am not familiar with this address. He walked me around the back and showed me "Dog", a large Akita type canine. I noted his enclosure, the housing he has provided and it all seemed adequate. I informed him because there was a weather advisory, and despite the dog had shelter, he needed to bring him inside until the advisory was over. He was pleasant and said he would do as I asked. I reassured him the dog was well cared for. He then announced that he wasn't even fond of the dog. I asked why he did not surrender him to a shelter and he said because I bought him and paid for him. As we were talking, the dog began barking and he stated, "I'm late with his dinner". I thanked him for showing me the dog and his living situation.....JS/P030355

Currently, Remy, Dutch and Trinity are all spayed/neutered. Remy and Dutch are current on rabies vaccinations and also licensed for 2017. Bryan has a fenced yard and kennel, as well as Kondo from Kane's Krusade. Upon Dutch's second to last reclamation Bryan stated she was planning to put up a new fence to prevent the dogs from getting loose.
