I. Open Session

The Chairperson announces the intent to enter into Executive Session pursuant to Mass. General Laws chapter 30A, Section 21 (a) (1), to determine whether to hold a hearing which involves the discipline or dismissal of, or complaints or charges brought against a public officer, employee, staff member, or individual, in the matter of; Special Order (SO) #25-033, unless the employee requests an open session.
