Communication: Emergency Euthanization Hearing for "Missy" who is Currently Impounded at TJO (hearing)

A brief synopsis of 341 Central/"Missy" history

"Missy" (and "Envy") declared Dangerous by Dog Hearing Committee in 2016 after dogs were loose from yard and bit Mr. Stone.

On 1/23/17 "Missy" was found roaming loose again in the area of Central Street and impounded at TJO. As roaming loose was a violation of the original Hearing Order, TJO pursued a follow-up hearing on 2/8/17 at which time "Missy" was ordered to be euthanized.

On 2/23/17 a court order was issued overturning the euthanasia order and ordering the return of "Missy" to her owner Meaghan Scott.

On 3/30/17 a letter was mailed to Meaghan Scott advising her to relicense her dogs for 2017.

On 5/1/17 a message was left on Scott's voicemail advising her the license renewal period was expiring and she needed to relicense her dogs.

On 6/7/17 a citation was issued for failure to comply with licensing requirements.

On 4/17/18 TJO received a call that two dogs, "Missy" and "Rosy" (a Rottweiler also owned by Scott) were loose and charging residents leaving a church service. Both dogs were found loose and impounded at TJO. "Rosy" was returned to the custody of Scott's partner; "Missy" remains impounded as TJO understands this to be an additional violation of the original Hearing Order; pending hearing.
