Dog Hearing on “Ryder” and “Blue Jay” of 27 Riverview ()

RESULT: MEETING CANCELLED

27 Riverview/Alton Llanos history

In 2007 TJO euthanized "Devious" owned by Alton Llanos after the dog was found inside an area home and the owner declined to retrieve him. Llanos has an outstanding bill at TJO for this service.

6/1/16-Officer Simpson went to 27 Riverview Street after receiving a complaint of 2 dogs fighting in a yard. Owner Llanos was not compliant or forthcoming with information during this visit and was cited. He was also reported to the MSPCA for concerns over lack of vet care for the dogs' injuries.

10/28/16-Animal Control received a complaint of 2 loose pit bulls in the area of Riverview Street, both were gone on arrival.

12/10/16-Both dogs, "BlueJay" and "Ryder," owned by Llanos, were picked up loose, impounded at TJO and returned to co-owner Crystal Lamb for \$380 (impound, board, leash law and spay/neuter violation, both dogs were current on rabies vaccinations and licensed at the time).

7/11/17-Animal Control received an online complaint that both dogs, "BlueJay" and "Ryder," got loose from their fenced yard at 27 Riverview and chased a woman and her dog. Owner Llanos cited again for leash law violations.

Llanos currently has the two adult dogs, "BlueJay" and "Ryder," and 3 puppies from their last litter. His yard is fully fenced and he has some locking mechanism(s) on the door. The adult dogs are licensed under Crystal Lamb but current on rabies under Alton Llanos in Tracker. Neither dog is spayed or neutered.

Officer Simpson arrived at 27 Riverview Street after a neighbor called Springfield Police about dogs fighting and the owner being bitten. The neighbor had heard the owner yelling and saying "throw hot water on that bitch." Upon arrival Officer Simpson noticed the owner Alton Llanos in the back yard with a towel taped around his right forearm. When asked about the injury Llanos claimed to have cut it on his car. Officer Simpson also observed 2 blue and white pitbull type dogs in the yard, one intact male and one intact female. The male appeared to be soaked with water and the female had several fresh puncture wounds on her chest and face. When asked if his dogs were licensed and vaccinated Llanos said "yes" and that he does it all himself at a location in South Hadley. Officer Simpson explained that if Llanos was not a vet he could not administer rabies vaccines and then tried to inform the owner of the home quarantine process. Llanos then became agitated saying no one was taking his dogs. Simpson again tried to explain home quarantine procedure and that the dogs would not be removed from the property, at which time Llanos stated "get the fuck off the property." Officer Simpson then left and completed the bite report despite Llanos's claim that there was no bite.

When Officer Simpson returned to the office an anonymous caller had left a message stating there was a 3rd white pitbull type dog with severe cuts that was hidden inside Llanos's home. Officer Simpson did not see this dog during the visit but informed Officer Christine Allenberg of the MSPCA of the situation for a follow up visit. An incomplete bite report was sent to Steve Stathis of the Springfield Board of Health. Llanos was issued a citation for 3 unlicensed and unvaccinated dogs (\$50 per violation, per dog) in accordance with 110-2, totaling \$300, citation # 207255. DogTracker lists 2 male pit bull type dogs to Llanos, named "BlueJay" and "Rider," both dogs are current on rabies and were licensed for 2016 on 11/22/16 (after the citations were issued).

Officer Mateo, stopped by this address after being notified about a possible dog bite incident yesterday via an online post sent from a TJO volunteer. Around 10:00 AM on 7/10/17 the 2 dogs from 27 Riverview, BlueJay and Ryder, owned by Alton Llanos, got loose and went after a person who was walking her dog. This person was later identified as Elizabeth Gurka at 13-885-6368, 47 Riverview, Springfield. During the altercation Gurka was walking her dog and was knocked down by Llanos's loose dogs. They also chased her and her puppy to her home. No bite occurred. Gurka has been advised of her right to request a dangerous or nuisance hearing on the dogs involved.

Spoke to Mr. Alton Llanos, who was aware of the incident, on 7/11/17 at his home. According to him, the little dog did not suffer any wounds. It appears that his male dog broke the latch on the gate and both dogs got loose. He fixed the latches, he said. He also said that he put multiple latches on the fence to prevent this from happening again.

In the past Mr. Alton has easily become upset when any Animal Control Officer had been to his property inquiring about his dogs. He blames the neighbors for calling and made some remarks about race. He states that since he bought that house some neighbors just complain, but none are the immediate neighbors, referring to the two neighbors right next to his property. Mr. Llanos has a new wooden fence all around his rear yard. He currently has three puppies left from the last litter which appear to be about 4 months old. He mentioned he never had any neighbor issues with his dogs at his former residence by East Street in Springfield. He is also planning to build a kennel for the dogs in his yard by the end of this summer.

Made him aware that we have received multiple complaints from the neighborhood and residents being scared about his dogs. We talked about breed, size, and how some people are simply afraid of dogs, as well as his goals and responsibilities to prevent any further issue is to keep his dogs in his property. EM

RABIES

RABIES - Rabies is a disease caused by a germ in the saliva of a "Mad" dog. The germs enter the body through the wound made when a rabid animal bites another animal or person.

SYMPTOMS - Rabies may appear in either the dumb or the furious form. The symptoms are not constant, but as a rule dogs with **DUMB RABIES** are very **RESTLESS**. The eyes taken on a peculiarly bright appearances, with dilated pupils. The dogs may be more **AFFECTIONATE** than usual. The throat and jaws gradually become paralyzed so that **MOUTH HANGS OPEN**, saliva **DROOLS** out, and the tongue seems to be in the way. There is difficulty in swallowing. Frequently these symptoms lead to the mistake of thinking the animal has a **BONE CAUGHT** in the throat. The dog may snap at imaginary objects.

Dogs affected with the **FURIOUS** form of **RABIES** become **IRRITABLE** and restless, **SNAPPING** at people or other animals. They will chew up foreign material such as rugs, pieces of clothing, or wood. They try to get out of the house to run. If confined, they will **TEAR** at objects and, if they break loose, will **RUN AIMLESSLY** for miles, snapping and biting at any moving objects crossing their path.

In both forms of rabies, there is a peculiar high pitched and **HOUND LIKE HOWL**. The end comes when the dog is exhausted, the legs become paralyzed, and the dog dies in a stupor. **RABIES NEVER APPEAR AS SUDDEN CONVULSIONS OR FITS**.

IF A DOG BITES A PERSON - Do NOT kill it. Confine the dog and call a veterinarian. The dog should be kept under observation. If it remains well, there is no danger of rabies to animals or persons bitten; if it has rabies, definite symptoms and death will occur within the two weeks' period of restraint that is required. If the dog is killed at once, you may never know whether or not it was rabid.

ALL PERSONS BITTEN BY OR INTIMATELY EXPOSED TO RABID ANIMALS SHOULD BE GIVEN ANTI-RABIC TREATMENT

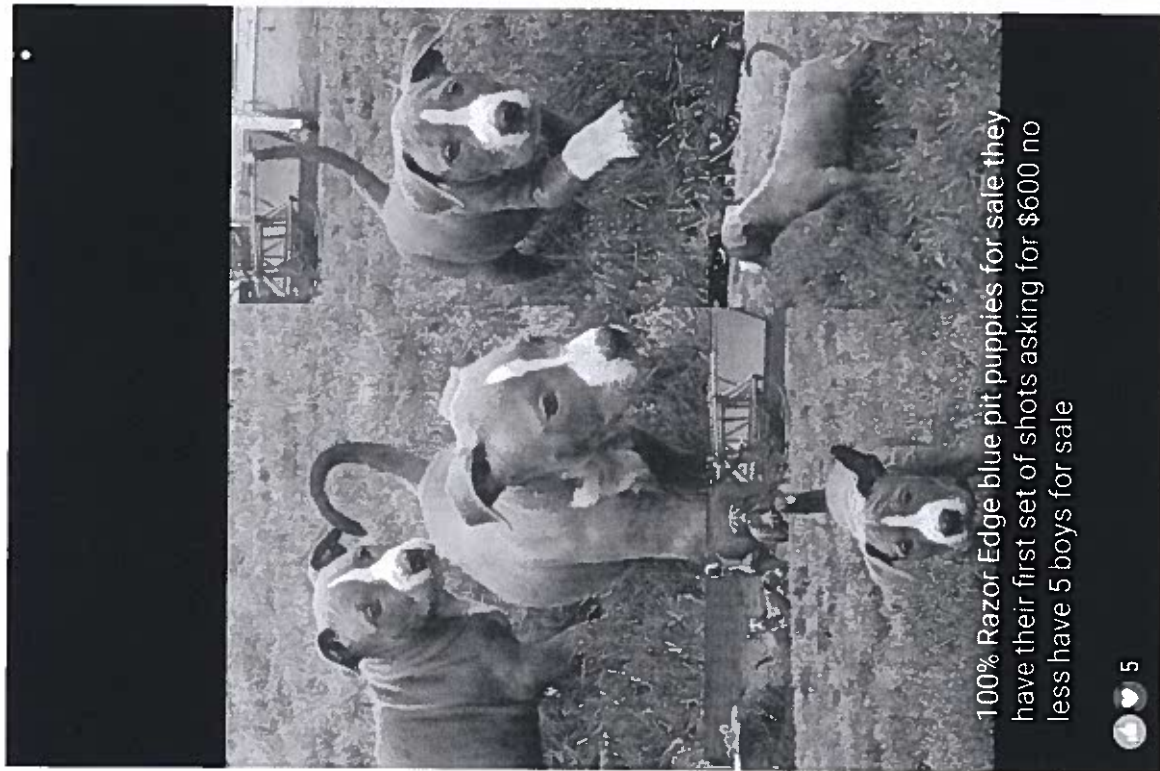

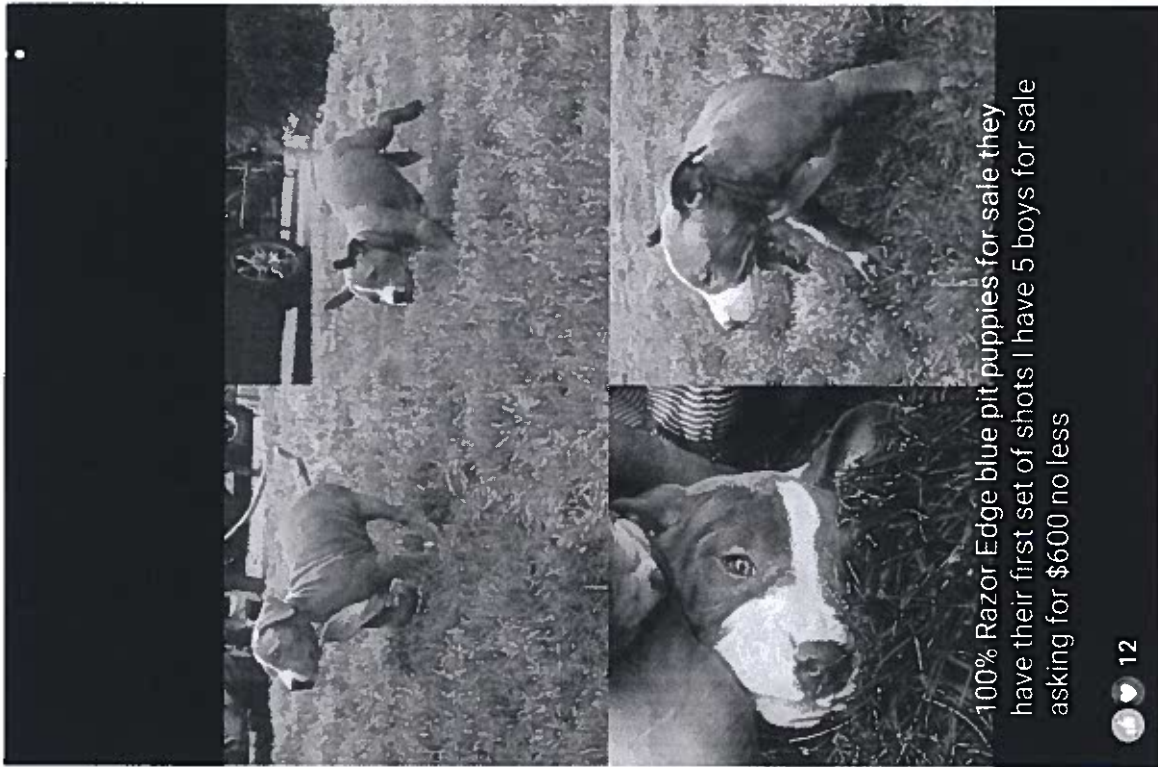

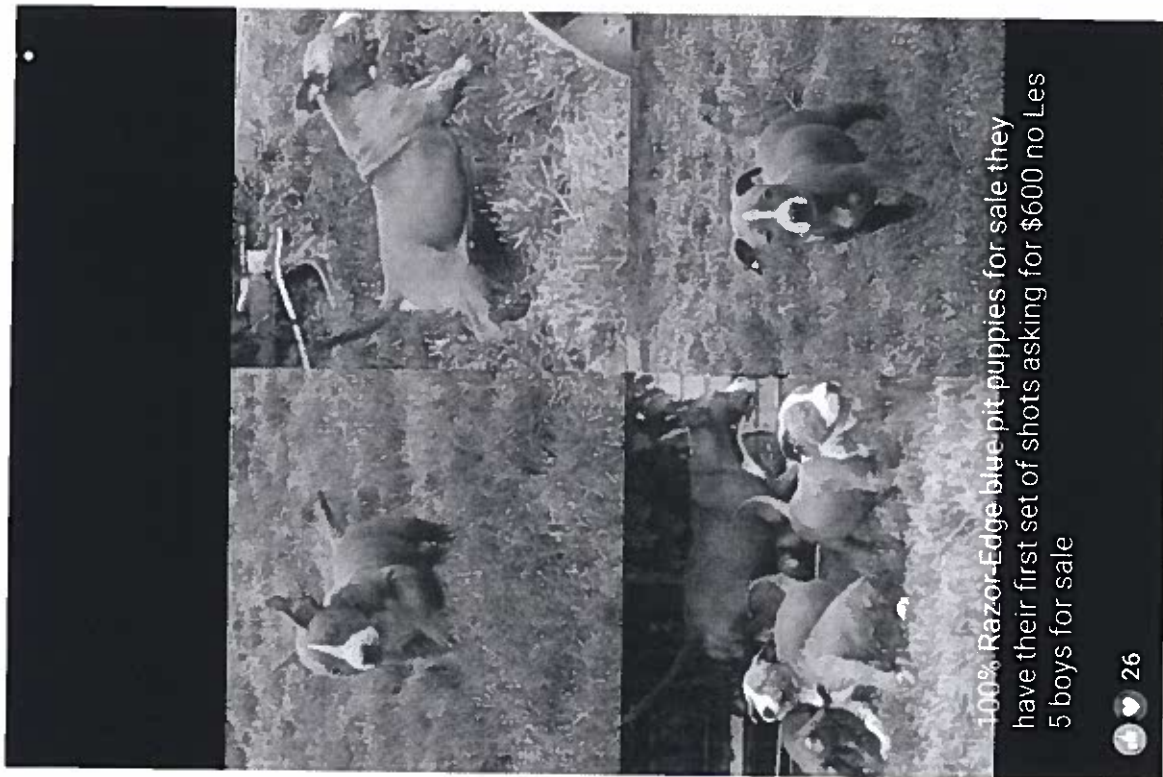

We the undersigned request the dogs on 27 Riverview St. be once again deemed dangerous in accordance with state law 136A, and removed from the premises in compliance with Massachusetts State Law 157 section h "(h) If an owner or keeper of a dog is found in violation of an order issued under this section, the dog shall be subject to seizure and impoundment by a law enforcement or animal control officer." The dogs have been continually threatening neighbors. The dogs once again got out August 11th, 2018. They aggressively came at a neighbor who happened to have a garden hose in his hand and sprayed them, which scared them off. We believe the homeowners have violated their agreement with the city and continue to be a nuisance to the neighborhood.

TJ O'Connor has had to respond:

06/01/16 A neighbor heard the dog on the owner being bitten, and heard the owner yell "throw hot water on that bitch" An officer arrived to find one dog wet, one with fresh puncture wounds and the owner with a towel around his forearm. He claimed to have cut it on a car.

There's two problems here 1) the owner was presumably bitten making the dogs dangerous, 2) the dogs were abused. Another neighbor called about a 3rd dog with puncture wounds in the house, again animal abuse.

07/11/17 Pit bulls knock down and and chase a neighbor on the porch

(iv) that the owner or keeper of the dog provide proof of insurance in an amount not less than \$100,000 insuring the owner or keeper against any claim, loss, damage or injury to persons, domestic animals or property resulting from the acts, whether intentional or unintentional, of the dog or proof that reasonable efforts were made to obtain such insurance

(h) If an owner or keeper of a dog is found in violation of an order issued under this section, the dog shall be subject to seizure and impoundment by a law enforcement or animal control officer. If the keeper of the dog is in violation, all reasonable effort shall be made by the seizing authority to notify the owner of the dog of such seizure.

a dog that either: (i) without justification, attacks a person or domestic animal causing physical injury or death; or (ii) behaves in a manner that a reasonable person would believe poses an unjustified imminent threat of physical injury or death to a person or to a domestic or owned animal.

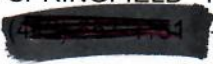

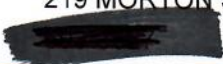
