The meeting was called to order on November 8, 2018 at 5:30 P.M. Commissioners: Peter Sygnator, Michael Siciliano and Andrew Cade were present with Rosa Espinosa and Ronald Senez being absent . The meeting was held at Springfield City Hall, 36 Court Street - Room 220-2nd Floor, Springfield, MA.

FIRST order of business -Approval of Minutes:

Approval of Minutes for Springfield Board of License Commissioners Hearing held on Thursday October 25, 2018

After discussion:

Commissioner Sygnator motioned to approve. Motion seconded by Commissioner Cade, with unanimous vote to approve.

SECOND order of business- Petitions:

Petition for a Change of DBA for Downtown Boyz, LLC d/b/a Wonderland located at 280 Chestnut St; Matthew Hubeny, Manager of Record.

Licensee appeared Pro Se.

After discussion:

Commissioner Sygnator motioned to approve. Motion seconded by Commissioner Cade, with unanimous vote to approve.

THIRD order of business-Pre Hearing Conference:

Adolfo's Restaurant located at 254 Worthington St; Victor Bruno, Manager of Record; Violation of 9-7-18- Patron under the age of 21 in licensed outdoor patio area of establishment after 11pm.

Licensee did not appear.

After discussion:

Commissioner Sygnator motioned to continue to 12/13/18. Motion seconded by Commissioner Cade, with unanimous vote to approve.

FOURTH order of business:

Malecon Restaurant located at 137 Chestnut St; Genesis Laura Pujols, Manager of Record; Violation of 9-9-18- Allowing the use of smoking material without required smoking bar permit.

Attorney Steve Reilly appeared on behalf of Licensee.

After discussion:

Commissioner Sygnator motioned that the Licensee served 2 days of suspension held in abeyance from previous violation and motioned a 5 day suspension with 1 to be served and 4 to be held in abeyance for 1 year for current violation. Motion seconded by Commissioner Cade, with unanimous vote to approve.
