Dear Hannah Orenstein:

On October 17, 2020 my family experienced a horrific ordeal. We let our 16-year-old dog outside, our home is a one family house with a fenced in yard. My mother hearing a lot of barking went to the door to see what was going on and there were what appeared to be two huge pit bulls in our yard. At this time, we were unsure how they had gained entry but both dogs had a part of our small terrier mix in their mouth. All my mother could do was scream as they gnawed and pulled at our dog. When she started screaming two boys opened the gate to our yard and came in after what seemed like for ever they attached the leash to the dogs and escorted them out of the yard and stood in the middle of the street in front of my house. My nephew hearing his grandmother screaming came running upstairs from the basement, seeing the young boys standing in the street with their dogs and our terrier lying motionless on the ground he yelled to them to get away from our house.

This incident occurred at three o'clock in the afternoon, my mother cried hysterically for the next seven hours before dosing off to sleep waking up occasionally to continue crying. Every time we went to let the other dogs outside, she would start screaming don't let them out don't let them out. We have had a dog for as long as I can remember and we know that nothing last forever, like humans they get old and die. But to witness such a brutal death was so traumatizing to my mother every time she closes her eyes; she relives that ordeal.

As dog lovers we understand that bad and malicious dogs are breed and raised not born. We have never had one of our dog's attacked or harm another individual. Just like children we take our dogs to the vet for yearly exams and immunizations, we buy them shirts to keep them warm in the New England weather, they go the groomers to get their hair cut and their nails trimmed. They are family and we treat them as such. I would never condone my children to go out and start fights for no reason and I would hope one would feel the same about their dog.

Due to the fact that these dogs made every effort possible to enter my yard and attack and kill my small dog for no other reason then to cause him harm, I believe these are malicious animals and

I would like to request a hearing so that I can share the evidence I have gathered to prove that these animals need to be put to sleep. 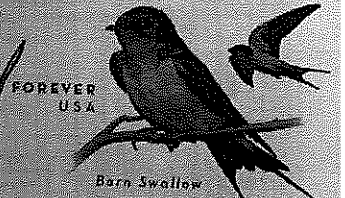
