Subject: [External] Dog Attack

On Wednesday, August 25, I was in the driveway with my granddaughter talking to another neighbor. We saw my nextdoor neighbor's 2 dogs coming towards us, a German Shepard and a husky. The German Shepard was going for my 2-year-old granddaughter. I lifted her just in time and turned my back to shield her from the dog. The dog bit me and broke the skin on my lower back. He then ran after and attacked a City recycle worker.

Previous occurrences:

- the German Shepard has run into my back yard and pinned me against my fence. I had a plastic tube that I was swinging at him to keep him at bay.
- another time my granddaughter and I were in the driveway going into my house when the dog was let out of a vehicle it was in and came across the driveway and went after us, I turned my back on it and was up against the garage, I was kicking my foot at it.
- one time we were playing outside the front of our house on the lawn. The dog ran onto our lawn and started barking and chasing us. I lifted my granddaughter up and got into the house just in time.

I have given my neighbor the benefit of the doubt but the attack last week was the final straw. I cannot take a gamble on my granddaughter's life. The owners do not have any control. The dog does not listen to them. They are in the process of putting up a fence after I asked them to. And the owner has told me that he is putting the dog to obedience classes but he didn't say where. Regardless of the fence, the dog has been let out of the front door and out of the vehicles numerous times, so a fence is not reassuring at all. I cannot take the chance on waiting to see if the obedience classes will work or not. We are terrified to be outside, we check the area anytime we are outside.

Concerned caller Denise reporting neglect and possible injuries to 2 dogs following an escape through a window. Denise reported both dogs were bleeding.

Upon arrival, I met both dogs and their owner. The dogs were clean, free of odor and without any injuries whatsoever. Owner reported they tore through a screen and were able to get outside. She denies they broke any glass. I did not see blood outside, broken glass, or anything to support Denise's allegation of neglect and injury. I noted a torn screen only.

Caller also reported both dogs are malnourished. Both dogs are well fed and of adequate body weight. Rocky is a NM and Ollie is intact. Ollie is lean and slender but not underweight.

I advised Narreau to get both dogs licensed within the next 2 weeks.....js

4/13/21 - Received a second call asserting that these dogs live in squalor and are skin and bones. Caller states she has video, so I recommended that she contact the Code Enforcement department to see if they can gain access for an inspection. She claims the video showed there was definitely glass broken and that the ammonia smell was as strong as is they have 40 cats. Caller is Taylor Batchelor 413-657-6480 and will have the person with the video reach out to Code. RMR

Finally able to MC with Soto and she was aware of the altercation, but said nothing happened besides people yelling at the dogs and there was a brief tussle. I confirmed there were no punctures, but the chihuahua involved, "Libby", did have a scratch on her underside. I explained there was no need for a quarantine, but addressed the leash law violations yet again. Soto claimed her daughter accidentally left the door open and dogs got out, but Soto was right after them and picked them up in her car, asked if everyone was okay, and proceeded to go back home. A citation was already in the mail for Soto since we still have no proof of vaccines, but she showed me stacks of paperwork in person, yet was unable to find any current ones except for "Karma" who we already had in Tracker as current. I advised she could appeal the ticket if she gets all dogs current and licensed by the end of July, but the LL violation would stand. Soto has had bite incidents in the past as well. Per Soto, she only has the 3 dogs now, "King", "Obie" and "Karma". During the altercation with the Chihuahua the victim knew that it was a gray and white pit bull and a brn/brindle one, and Soto confirmed it was "Karma" and "Obie" who were involved. SPD called in a dog bite at 83 Cuff Ave stating a dog vs. person.

Right after Beverly Lopez, the wife of the victim Cory Mattoon, called to report a dog bite at the same address where a dark colored pit bull came through their gate, into their yard, and attacked their 2 dogs "Daisy" and "Savage" and Mattoon got injured in attempts to separate the dogs - per SPD he had a large laceration on R hand and punctures on both R/L hands and R arm, he was treated by EMT's before I arrived.

Per Lopez, the loose dog opened their gate on its own and went after their small dog "Savage", bit her shoulder/ear but obtained no wounds (on arrival I touched the spots that were covered in saliva on "Savages" neck/shoulder area and did not feel any bumps/scrapes/holes/blood, I told the owner to further examine when settled more and report to a Vet. if wounds were found), then larger dog "Daisy" got involved and she received wounds on her head/face/neck - "Daisy" was treated the next day at VESH where her wounds were clipped and cleaned and she was given a rabies booster and pain meds.

Cory Mattoon was taken via ambulance to Mercy Hospital where he received sutures, per Lopez, for a laceration obtained during the separation, also per Lopez he had several bite punctures on his hands/arms that were cleaned - per the medical record Lopez provided for us, Mattoon was given a tetanus booster, pain meds, and antibiotics and referred to an Orthopedic.

Their son Elijah Mattoon, 12 years old, also stated he was possibly injured from the dogs, but unsure which one - when talking to SPD, he described that he was trying to separate the dogs and fell in the yard but thinks the superficial scrape on his L leg was from a dogs' toe nail and it is unknown how the small wound on his L hand was obtained

Yadira Soto from 100 Cuff Ave. is the owner of the loose dog that went onto the property of 83 Cuff Ave.

Soto reported it was her dog "King" that got loose after she was walking him and let go of the leash when he pulled away to chase the children/dogs that were playing in the yard of 83 Cuff Ave. - "King" is a gray/white, male, Bully breed, short and stocky with a large head.

Soto reported that she told everyone to remain calm and "King" would not hurt the kids, but he was attempting to play with the dog and all the commotion enticed him more and then she was unable to enter the property to separate her dog because Cory Mattoon came out with a kitchen knife, threatened her, and starting hitting "King" himself - "King" obtained wounds on the bridge of his nose and inside his mouth, he was actively bleeding on my arrival and I was unable to assess what type of injuries he had and recommended Soto bring him to NEVCCC ASAP - we have yet to receive any medical update on "King"
